Public Works Committee Meeting Minutes

September 12, 2019

1. **Call to Order** – The Public Works Committee was called to order by B. Eastman at 9:00am.
2. **Public Comment** - None
3. **Adoption of Public Works Committee August 8th, 2019 Meeting Minutes** – F. Risler motioned to approve the August 8, 2019 meeting minutes as presented, J. Kusters seconded the motion. Motion carried 4-0.
4. **2020 – 2024 CIP** – The Commission was provided with the 5-year capital improvement program. R. Pritzlaff stated that approx. 3 miles of paving will be completed next year. The only major project for 2020 will be the completion of Emmertsen Rd.
5. **Traffic Control Request – Intersection of Oregon Street and Ridgeway Avenue** – Village Staff received a complaint from a resident regarding the uncontrolled the intersection at Oregon St. and Ridgeway Ave. All other streets intersecting Ridgeway Ave. have yield signs, except for the intersection of Oregon St. and Ridgeway Ave. Staff would like to add yield signage to the uncontrolled intersection. F. Risler motioned to add yield sign, J. Kusters seconded the motion. Motion carried 4-0.
6. **Pike River Trail Crossing at STH 11 – Discussion** – The Commission was provided with information regarding the HAWK Beacon system. The HAWK system is reserved for high traffic and high pedestrian intersections. This will be a state maintained signal due to this being a state highway.
7. **Committee and Staff Reports**
 - **R. Pritzlaff - Emmertsen Road Reconstruction Update** – The design is complete and the project will be bid out in January 2020.
 - **16th St. Reconstruction Update** – 16th St. is open up until the roundabout from both directions. The roundabout is estimated to be completed by November 22, 2019. All landscaping and signage has been completed.
 - **2019 Paving Program Update** – The Settlements at Hoods Creek is the only area that still needs to be completed. Staff is waiting for the developer of the area to install the curb.
 - **Compost Site Construction Update** – The compost project has been started and this Saturday will be the last day to use the site as is. The estimated completion for the project will be the end of October. A temporary site has been set up at the DPW Building.
 - **Howe Street Construction Update** – Construction is expected to start next week and will last approx. 2 weeks.
 - **Lathrop Avenue Drainage Construction Update** – The project is underway and all of the crossings have been installed and paved.

8. **Adjourn** – J. Kusters motioned to adjourn the Public Works Committee meeting at 9:33 am, F. Risler seconded the motion. Motion carried 4-0.
