Public Works Committee Meeting Minutes**

June 10, 2021

1. **Call to Order** – The Public Works Committee Meeting was called to order by F. Risler at 9:00am
2. **Public Comment** – None
3. **Adoption of Public Works Committee May 13, 2021 Meeting Minutes** – J. Schneider motioned to approve the May 13, 2021 meeting minutes as presented, F. Risler seconded the motion. Motion carried 2-0. J. Kusters abstained.
4. **Citizen Complaint – John Wells – Request for Driveway Curb Head Cut** – Village Staff received a complaint requesting the driveway curb head cut for the Ponds of Summit View Condominiums. J. Wells (President of the Ponds of Summit View Condominiums) had made a verbal agreement with R. Pritzlaff (former Village Deputy Director of Public Works) that corrective work to the driveway would be completed by the Village. J. Wells expressed his concerns that a Village staff member had made an agreement with him on this issue and the Commission is now questioning that decision. J. Schneider motioned to forward the request to the Village Board, with recommendation to approve based on the special circumstances of this specific item, but to make clear that it is not Village policy to address defects on private drives during the Village paving projects. J. Kusters seconded the motion. Motion carried 3-0.
5. **Discussion and Possible Action – Recommendation for Award of Contract – Campus Park Pickle Ball Court Construction** – Village staff recommends that current plans for construction will be adequate for long term use and approval of the construction bid. J. Kusters motioned to accept the Poblocki Paving Corporation base bid of \$163,567.00 for the Campus Park Pickle Ball Courts, J. Schneider seconded the motion. Motion carried 3-0.
6. **Discussion and Possible Action – Resident Requests for Speed Hump Installation on Village Roads** – Staff has received several requests for speed humps in local subdivisions. Speed humps were installed in the Rolling Fields subdivision to address increased traffic cutting through these roads to avoid construction on the two State highways adjacent to Rolling Fields. This was a special circumstance case; it is not the Village's policy to install speed humps. J. Schneider motioned to continue the current policy of not adding speed humps in subdivisions, J. Kusters seconded the motion. Motion carried 3-0.
7. **Discussion and Possible Action – Request for Street Light Installation – Shadow Wood Subdivision** – Staff received a request from the Shadow Wood HOA to install streetlights in their subdivision due to recent home invasions and burglaries. The Commission discussed that streetlights are normally put in place to indicate where intersections are located. J. Schneider motioned to deny the streetlights to be added in the Shadow Wood Subdivision, J. Kusters seconded the motion. Motion carried 3-0.

8. Committee and Staff Reports

- **T. Beyer – 2021 Paving Program Update** – Coachlamp Ln., Esquire Ln., Percival Ln., and Brougham Ln. have all been pulverized and the broken curbs have been repaired. Resurfacing of these roads is expected to start soon, and then the paving program will move to start on West Rd.

9. Adjourn – J. Kusters motioned to adjourn the Public Works Committee meeting at 9:57 am, J. Schneider seconded the motion. Motion carried
