### Public Works Committee Meeting Minutes, February 13, 2014

1. **Call to Order**
2. **Public Comments:** Doug Marks; a resident at 8021 Old Spring St. proposed a 4-way stop at the uncontrolled intersection of 90th and Old Spring St. The request is for the Village of Mount Pleasant place stop signs within that intersection.
3. **Adoption of Public Works Committee December 12<sup>th</sup>, 2014 minutes-** F. Risler motioned to approve. R. Anderson seconded the motion. Motion carried 4-0.
4. **Street Right-of-Way Deficiency Correction; Update-**
  - a. **Cottage Drive:** B. Sasse stated that a Public Informational meeting was held on January 21<sup>st</sup>, 2014 for residents of Cottage Drive. Due to various property owners opinions The Village suggested to present a presentation to the property owners which would explain and offer more options.
  - b. **Oakwood Drive:** B. Sasse stated the Right-of-Way parameters have yet to be determined and the Oakwood property owners were advised by B. Sasse that the correct documentation will be provided to them that will further explain the Right-of-Ways.
5. **Recommendation to Authorize the Temporary Lifting of Weight Limits (Section on Chicory Road for Lathrop Avenue Detour, Meachem Road to Lathrop Avenue; Racine County Reconstruction of Taylor Avenue); Racine County Reconstruction of Taylor Avenue).** - B. Sasse stated that he was looking for approval from the Village Board for the lifting of the 3 ton weight limit restriction and detour route for Lathrop Avenue. B. Sasse also stated he had spoken with Racine County and parties agreed to the acceptable alternative.
6. **Paving Program 5 year CIP: Draft Revision Based on Projected 2014 Funding Limits-** B. Sasse stated there was a limit to which the Village Board was budgeting for. The 5 year CIP showed that Prairie Dr. and Springlake Dr. subdivision area wasn't funded and were pushed into the 2015 Paving Program and were to keep the same criteria. B. Sasse stated he will within a month present a full CIP with adjusted



dollar amounts based on recent bidding information. 2015 paving Program will include the Green Hays project and B. Sasse suggested that Public Informational Meetings would begin to be beneficial. The repaving on Braun Rd will be a joint project in 2016 with Sturtevant and costs are yet to be determined.

**7. Engineer's Report:**

- **WDOT CMAQ Grant for Pike River Pathway-Phase 4 Status-** B. Sasse stated that the final acquisition for the property and will go back to the DOT to certify the Right-of-Way. Scheduling was for June 2014 but will be pushed back due to inactivity of the project.
- **Municipal Water Extension Survey; Globe Heights Subdivision area sent out-** B. Sasse stated that there were a total of 115 letters sent out to residents. The return due date for responses are February 28<sup>th</sup>, 2014 and the information will be reported at the next Public Works meeting scheduled on March 13<sup>th</sup>, 2014.
- **Date Set for STH 31: Washington Avenue to CTH MM- 30% Plan Review Meeting-** B. Sasse stated the project will be an 80% DOT and 20% Village split; including the sidewalks in the project. The Meeting is scheduled for February 26<sup>th</sup>, 2014.
