November 13th, 2014

1. **Call to Order-** Public Works Committee meeting was called to order by R. McCluskey at 7:30 a.m.
2. **Public Comment:** None
3. **Adoption of the October 9th, 2014 meeting minutes:** M. Callewaert motioned to adopt the October 9th, 2014 Public Works meeting minutes. F. Risler seconded the motion. Motion carried 5-0.
4. **Consideration for recommendation to Request Wisconsin DOT to install Sidewalk on Green Bay Road with State Resurfacing Project: STH 31, STH 20 to CTH to MM; Project ID 2390-09-00. Report of Survey Responses-** B Sasse reported out the summary of survey responses compiled regarding the installation of sidewalk on Green Bay Road, between Washington Avenue (STH 20) and CTH MM. He explained the exhibits presented depicting responses pertaining to the specific areas of interest to have sidewalk installed. According to the Southeastern Wisconsin Regional Planning Commission- Vision 2050 public input surveys, results of surveys indicated the majority support to increase accessibility to sidewalks for residential/pedestrian use. R. McCluskey called for a Roll Call vote. F. Risler motioned recommend the Village Board request the Wisconsin Department of Transportation install sidewalk on behalf of the Village of Mount Pleasant as recommended by staff as part of Project ID 2390-09-00; including all properties not currently having sidewalk; on the west side of STH31 between STH 20 and Newman Road, on the east side of STH 31 from STH 20 to Graceland Blvd. including the south side of Kinzie Avenue between STH31 and the Village Limits, along the commercial properties in the southwest quadrant of STH 31 and CTH MM, and along the south side of Washington Avenue east of STH 31 to the project limits. Callewaert seconded the motion. Motion carried 5-0. (Roll Call Results See Attached)
5. **Review Status of DOT Plans for STH 11: STH 31 to Kentucky Street; Project ID 2260-00-71-** B. Sasse stated the DOT plans to move forward with design and presented the 30% plans and note

specific design elements. Specifically it was noted that questions of access were presented and identified the Oakwood Drive connection and the need for the Village to proceed with acquisition of right-of-way. No action was taken.

6. Engineer's Reports:

- **Status and Paving Problems on 2014 Paving Program-** J. Seitz explained the areas of Braun Road, Foxwood & Spring Lake Drive that are in active construction. B Sasse stated there was a cost over run because of bad soil in Spring Lake and additional milling needed on Braun Road. Projects will run into next year's paving program due to unseasonably cold weather.
- **Status of Pike River Pathway (CMAQ) Paving-** The Pike River Pathway contract has been awarded. Preparation to install concrete pads has been started, grading of the path has not started, and because of the unseasonably cold weather paving will be held until the Spring of 2015.
- **Compost Site Chipped Wood Disposal Update-** M. Benish reported he is seeking additional ways of brush disposal. An estimate has been received from one contractor. Also he had discussed the spreading of chipped material on the farmed areas with the farmer who rents farm land from the Village and he doesn't recommend the spreading of the chipped brush onto the fields.
